

## 特别声明

本《特别声明》适用于 JUMIA 及其关联公司（包括但不限于 JUMIA 在其他国家合法登记注册的网络平台，以下称“JUMIA”）提供的产品和服务及其延伸的功能（包括“本地币汇款服务”建议），现在及将来可能开发的其他 JUMIA APP、网站、客户端、小程序以及随技术发展出现的新形态向提客户供的各项产品和服务。如 JUMIA 提供的某款产品或服务有单独的隐私政策或相应的用户服务协议当中存在特殊约定，则该产品的隐私政策将优先适用，该款产品隐私政策和用户服务协议未涵盖的内容，以本《特别声明》的内容为准。

## Special Statement

The *Special Statement* is applicable to the products and services and their extended functions (including the proposal of the “Service of Local Currency Remittance”) provided by JUMIA and its affiliates (including but not limited to the Online Platforms legally registered by JUMIA in other countries, hereinafter referred to as “JUMIA”), other JUMIA Apps, websites, client sides, applets, and various products and services provided for Customers in new forms that may be developed currently and in future as technologies develop. In the event that a separate Privacy Policy or special

provisions in corresponding User Service Agreement are provided by JUMIA for its certain products or services, such Privacy Policy shall prevail. Anything not covered in such Privacy Policy or User Service Agreement shall be subject to the contents of the *Special Statement*.

When a Customer chooses to purchase or use the products and/or services of JUMIA on JUMIA's Global Online Platforms, or chooses to upload relevant information of his/her company or of himself/herself (including sensitive personal or enterprise information, etc.) at his/her own discretion on JUMIA's African Online Platform on which the Customer has registered an account, the Customer shall bear the corresponding legal responsibilities for such information provided and uploaded by him/her. For the purpose of payment collection, JUMIA's African Online Platform suggests that Customers upload the above-mentioned information registered by themselves, and will collect and use relevant information of Customers through its Online Platform in order to provide products and services. **Nevertheless, this Website only reprints or explains the notices or suggestions on JUMIA's African Website. JUMIA shall not collect the above-mentioned information of Customers when Customers browse this Website and search on it. The payment collection mode for local currency is only reprinted by this Website for Customers' reference, which Customers shall have the right not to accept but stick with their previous payment method. In this way, they will not have to upload any personal information or company information to JUMIA's African Website.**

For the purpose of the product service, JUMIA's various global online platforms will, in the principles of legitimacy, legality and necessity, collect and use the information offered by Customers in their use of the products and/or services, or the information generated by their purchase or use of the products and/or services, or obtain relevant information of Customers from a third party through respective platforms. Unless otherwise stipulated by laws and regulations, or otherwise agreed by and between JUMIA and Customers, JUMIA's Online Platforms shall not share or disclose Customers' personal information and sensitive information. In the event that JUMIA's other affiliated companies or affiliated websites intend to use the personal information or sensitive information voluntarily provided by Customers and collected on their respective platforms for other purposes unspecified in the Statement or User Service Agreement of their respective platforms, or use the information of Customers collected for specific purposes for other purposes, JUMIA will notify Customers of such actions in a reasonable way and obtain another consent from Customers before using such information.

JUMIA attaches great importance to the information security of Customers, and will take all reasonable and feasible measures to protect the information of Customers.
